## 1. PRELIMINARY MATTERS

## 3. NZUSA

The AUSA President began the conversation by explaining the relationship and dynamic between AUSA and NZUSA over the years. It was noted that previous AUSA Executives had concerns regarding AUSA's membership with NZUSA, specifically highlighting the interaction of NZUSA at a national level and student levies. The AUSA Executives have continuously voiced their concerns that they have not been receiving the benefit worth the levy paid. AUSA had previously and continues to voice such issues/concerns but has not resulted in any significant reformation to date. As a result, the AUSA Executive has decided to bring back the vote to the students in good faith, in accordance with the Annual General meeting in 2021, to leave NZUSA which has already been passed by the Executive and endorsed by the Student Council.

The AUSA President highlighted the impacts it might have on the NZUSA partner associations (Te Mana Ākonga and Tauira Pasifika), and how AUSA will continue to support their kaupapa, the student's national voice, and maintain a such relationship.

The floor was opened for discussion:

An association member enquired regarding the statistics regarding student support (e.g. Food Parcels, Hardship grants). The AUSA WVP states that such details are still being processed although will be reported in AUSA's Annual Report.

#### THE VOTING SYSTEM WAS OPENED AND CLOSED AT 12:50

#### CHAIR

That the student body accepts the proposed recommendation:

- At the end of the 12 months' notice, 2 June 2022, AUSA will cease being a paying member of NZUSA, terminating their membership as per the NZUSA Constitution
- AUSA will uphold their commitment to work with Te Mana Ākonga and Tauira Pasifika to ensure Māori and Pacific voices are heard on a national level.
