MSO: Zui Kaiārahi to meet with the presidents. National student conference in August. Consultation with EY for students. Maori graduation, over 500 people.

5. STANDING AGENDA ITEM: GM UPDATE

- On track financially.
- Tough market commercially, but doing well with sponsors. No appetite for Craccum advertising at the moment.
- On track with expenses.
- Operationally: ReO H&S is a focus. Security cameras and panic alarms reception and exec office. Uni security will turn on cameras if an alarm is triggered. Lock the doors at night!

- Spaces locks on offices. C space is cold retrofit heaters into the light fittings perhaps, but looking for plan B. Leaks in womenspace, fixing problem as it happens.
- Zoe, the marketing specialist, has started. UBIQ employee, service level agreement 30% time at AUSA. The UBIQ website is supposed to launch today.
- Following up with the auditors on consolidated accounts has not been done in recent years.
- Student voice conference planning is continuing.
- 287 matters gone to advocacy.
- The phone line works. Sharon's office & reception.

Exec reviewed the Proposed Election Rules & Role Descriptions.

Edits to make to the election documents:

- Treasurer-Secretary role description to be fixed, should be changed to Finance and Operations Vice-President.
- PG committee to change the name in light of the name change to "PG Consultation Committee"
- Terms to start December 1st, rather than December 2nd.
- PGO is still to chair the PG Consultation Committee rather than EVP PG.
- \$250 resources clarify that this is the candidate's OWN MONEY and not AUSA giving \$250 to each candidate.

Nothing in the Constitution to enforce the rules? To check returning officer discretion.

• Nominations open on the 22nd of July.

PISO arrived via Zoom at 1 pm.

CHAIR/ZUBAIR (EVP)
