- 28k more spent in Orientation than budgeted.
- Likely going to be spot on for end of the year.
- November CPI adjustment from the university should be a well-needed boost. Inflation is running high at the moment.
- ReO was on track from a budget standpoint.

Operationally, elections are the focus at the moment.
